#### **Benefits of Associate Membership**

Associate members are eligible to

#### Eligibility

*Teacher* means a person holding a permanent or temporary certificate of qualification as a teacher issued by the minister under the *Department of Education Act*. Teachers and substitute teachers\* employed by an Alberta public or separate school board are eligible for active membership.

Associate membership is available to

- school board superintendents
- teachers employed by the Government of Alberta
- members of the faculties of education of Alberta universities
- teachers employed as faculty members in public colleges
- teachers engaged in teacher education in private colleges affiliated with Alberta universities
- teachers in private schools or kindergartens
- teachers in Alberta schools operated by the Government of Canada
- teachers employed by the Association or any of its local associations
- unemployed teachers
- teachers pursuing further studies full time
- retired teachers
- teachers employed in community education programs operated by agencies other than school boards
- teachers employed by the Alberta Teachers' Retirement Fund board

- teachers employed by charter schools
- Elders, Knowledge Keepers, Cultural Advisors and noncertificated educators employed by First Nations school authorities
- nonteacher professionals employed by school boards (social workers, psychologists, therapists or clinicians)
- other people the Provincial Executive Council designates (subject to the ratification of the Annual Representative Assembly)

\*Note: Substitute teachers employed by public and separate school boards are considered active members from the date on which they first actually teach until the end of the school year or until they are no longer on the approved substitute roster of a school board, whichever occurs first.
